### COMPLETION OF CAPITAL RAISING

The directors of Diatreme Resources Limited are pleased to confirm the funds from the share placement to sophisticated investors announced on 15 March 2013 have been received.

As outlined in the Company's Notice of 2013 Annual General Meeting dated 26 April 2013, the 1<sup>st</sup> tranche of 4,797,363 shares have been issued at 2.5 cents per share to raise \$119,934 before costs.
