Notice under Section 708A(5)(e)(i) of the Corporations Act 2001 (Cth)

On 4 February 2022, Diatreme Resources Limited (ASX: DRX) (the **Company**) issued 9,150,000 fully paid ordinary shares (**New Shares**) resulting from the exercise of 9,150,000 (unlisted) options by shareholders of the Company, at the exercise price of \$0.02 (2.0 cents) per option.
